WHEREAS the Council has reviewed the bid documents related to the inventory of septic systems within the municipal territory;

WHEREAS the Council members have been informed of the decision summary prepared by the Chief Officer Administrator and Clerk-Treasurer ;

WHEREAS the Municipality has received two compliant bids;

WHEREAS the company Gestion Septique BR, has submitted a bid amounting to \$672,983.20;

WHEREAS the company SEPTIPRO, has submitted a bid amounting to \$556,433.01;
